1. Approval of Board Agenda

DILLON is wondering if a member of the Presidential trio should be in attendance when a new member is being onboarded by the previous member in that role (ie. Previous Treasurer onboarding new Treasurer with a member of the Presidential trio in attendance) and notes being taken during onboarding. DILLON wondering if good questions would also be asked such as: what you want to accomplish, what goals do you have, etc. ALL agree. NATHAN plans on doing monthly one-on-ones with all members of the Board during his term as President. The purpose here is to offer support and gauge confidence of each Board member. TESS, might be a good idea to create annual checklists to keep Board members on task with what is needed during times of the year. MEGHAN, yes I think that would be super helpful. DILLON, yes some Board members have some semblance of this idea (LEAD Chair especially), but not other Board members. This sounds very valuable.

6. Awards and Selection – Board Meeting March 14-18

7. Advanced Nomination Solicitation

DILLON, for the four open positions to be voted in at the AGM, please push this interest to folks you know that would do very well. MEGHAN, yes please tap members on the shoulder for these positions. MEGHAN, as much as we want advance nominations, we will still accept from the floor correct. DILLON, yes. It is still a great idea to have names and interest in advance.

8. Master Plan Walkthrough and Feedback
