1. Approval of Board Agenda

PARUL motions to approve the agenda, COLE seconds the motion. Agenda approved. No additions or changes.

2. Approval of Past Board Minutes

COLE motions to approve the past Board minutes (November 6th 2022), EMILY seconds the motion. Past Board minutes approved. No additions or changes.

3. LEAD 2023

BRIANNA has reached out to Gull Lake Centre for 2023 dates. Potentially in October, after Thanksgiving. Waiting to hear back from Gull Lake for a confirmation. Biggest question currently is 'do we engage student leaders on the committee this year' as per the situation that occurred this past LEAD with a specific student leader who was also on the planning committee. 4. NWACUHO 2023 Update

TESS has indeed heard from the Hyatt about a room for the AGM/35th. Some questions back and forth with TESS and the Hyatt. AV / stage questions. TESS asked the Hyatt to price out some coffee and tea...as well as prices for potential dinner. MEAGHAN, yes we are also looking into other options due to costs that are more appealing. UofC has space available and TESS mentioned that Mount Royal has space available as well. TESS, would lean towards UofC as they are on the C-train track. There are great options downtown for food and private dining that are close to the Hyatt.

TESS, the last we checked, NWACUHO Annual Conference had 86 attendees. The early bird has closed but RLPA members can still get RLPA rates, they just need to email TESS for the discount code. NATHAN, does the Hyatt rooming block have a deadline on the NWACUHO block? TESS, I don't believe so but they would probably have that block until filled.

5. AGM 2023

a. Agenda

NATHAN, just finalizing the registration page. It is coming very quickly. NATHAN wants the focus for members to be that this is an opportunity to get us (members) all together. The cost for the day (both events together) will be \$200. This would also include a mid-day refreshment break as well as the evening meal. Refund date will be prior to February 1st. The Student Staff Leadership Awards weren't included as we received feedback that, in February/ March, it is a bit early for pro-staff to know who they want to nominate until after the AGM. Using digital certificates has worked well in the past. Nominations could come out in March for these awards. We still have the New Professional Award, Josie Lamothe award and Mark Chytracek lifetime award. We have a meeting on the books to look at nominations near the end of this month and make decisions...order plaques, etc. Idea would be to award these at the 35th Dinner. We are hopeful for nominations for us to be able to give out awards.

e. Master Plan Update

NATHAN, this will be a fluid update at the AGM to encourage that this is a living document. We will mention the work from the members that have already added to the Master Plan. Committee work has been impactful here. **Master Plan document** attached to these minutes.

f. Committee Activity
